# VIG Czech Short Term Bond Investment Fund

## INVESTMENT POLICY OF THE FUND

The Fund aims to increase the value of its assets under management and to provide investors with a higher yield than Czech bank deposits and short-term bonds over a period of 1 to 2 years. No individual investor's decisions can be made in the Fund. The Fund Manager selects portfolio elements in accordance with the above principles. When making investment decisions, the tools of fundamental analysis and technical analysis are used, and the current market sentiment is also taken into account. The Fund primarily invests in discount treasury bills issued by the Czech State, sovereign bonds, bonds of quasi-sovereign companies, or bonds or deposit-like instruments issued by the Czech National Bank, the European Central Bank or the central bank of another Member State of the European Union. To a limited extent, the portfolio may include government securities, state-guaranteed bonds, corporate bonds (including those issued by financial institutions) and mortgage bonds with at least investment-grade credit rating. Investments may be made in Czech crowns or, to a limited extent, in other currencies. In the case of assets denominated in a currency other than Czech crowns, the Asset Manager shall strive to fully hedge foreign exchange risks (there cannot be a difference of more than 5% between the currency exposure of the derivative transaction and that of the asset to be hedged).

The Fund may enter into deposit and reportransactions, invest – to a limited extent – in units in collective investment undertakings, and derivatives may as well be used (for the purposes of hedging or building an efficient portfolio).

### MARKET SUMMARY

The Czech National Bank (CNB) reduced rates by another 25bps to 4.25% in late September, with all but one board member in favor. Governor Ales Michl noted that inflation had been higher than anticipated in recent months, prompting the need for a gradual reduction in interest rates. Persistent price growth in the service sector and tight labor market conditions remain key inflationary risks. Additionally, the renewed rise in real estate prices, along with an unexpected increase in the fiscal deficit, could further pressure inflation.

However, the CNB also highlighted significant anti-inflationary risks, including deteriorating global economic conditions and weaker performance in the German economy. Subdued demand from European trading partners, driven by both cyclical and structural factors, may justify more aggressive easing from the European Central Bank.

Some CNB members acknowledged that the rate-cutting process might pause as interest rates near their long-term neutral level. Despite the recent actions, core inflation risks remain, especially in the service sector, where price dynamics have shown resilience. The rise in non-tradable goods prices (excluding regulated prices) increased to 4.4% in August, and a potential uptick in market and imputed rents could become evident early next year. We still have 2 monetary policy meetings this year. As market pricing is quite stretched, there is a chance for disappointment, especially if US macro data

starts to improve. As a result we turned to a slightly more cautios positioning at the end of September.


