INVESTMENT POLICY OF THE FUND

The Fund aims to increase the value of its assets under management and to provide investors with a higher yield than Czech bank deposits and short-term bonds over a period of 1 to 2 years. No individual investor's decisions can be made in the Fund. The Fund Manager selects portfolio elements in accordance with the above principles. When making investment decisions, the tools of fundamental analysis and technical analysis are used, and the current market sentiment is also taken into account. The Fund primarily invests in discount treasury bills issued by the Czech State, sovereign bonds, bonds of quasi-sovereign companies, or bonds or deposit-like instruments issued by the Czech National Bank, the European Central Bank or the central bank of another Member State of the European Union. To a limited extent, the portfolio may include government securities, state-guaranteed bonds, corporate bonds (including those issued by financial institutions) and mortgage bonds with at least investment-grade credit rating. Investments may be made in Czech crowns or, to a limited extent, in other currencies. In the case of assets denominated in a currency other than Czech crowns, the Asset Manager shall strive to fully hedge foreign exchange risks (there cannot be a difference of more than 5% between the currency exposure of the derivative transaction and that of the asset to be hedged).

The Fund may enter into deposit and repo transactions, invest – to a limited extent – in units in collective investment undertakings, and derivatives may as well be used (for the purposes of hedging or building an efficient portfolio).

MARKET SUMMARY

In November 2024, the Czech Republic's economy continued to grapple with elevated inflation, sluggish growth, and cautious monetary policy adjustments. The Czech National Bank (CNB) reduced its two-week repo rate by 25 basis points to 4.00%, in line with expectations, though not unanimously. Amid this shift, inflationary pressures persist, with forecasts suggesting headline inflation could surpass 3% by year-end, peaking at 3.4% in December. This is driven primarily by rising costs in housing, food, and services, while a weaker koruna and high energy prices amplify inflation risks. Declining fuel prices have provided some relief but are expected to stabilize by early 2025. Despite a mildly negative output gap, structural supply-side constraints, including weak productivity, chronic underinvestment, and deteriorating labor skills, might keep inflation elevated. GDP growth remains tepid, with Q3 figures showing a 0.4% quarterly and 1.3% annual increase. Robust household consumption, driven by 7% wage growth, contrasts with contracting fixed capital investment, raising concerns about long-term economic stability. The CNB faces a complex challenge: balancing inflation control with economic recovery while navigating external risks, such as potential U.S. trade tariffs and weak eurozone demand. Analysts anticipate a pause in rate cuts at the December 19 meeting, with cautious easing potentially resuming in March 2024. However, structurally higher inflation and economic vulnerabilities may prompt a more hawkish stance, complicating efforts to support growth without undermining stability. The broader European economic slowdown adds to the uncertainty, requiring vigilant policy navigation to mitigate inflation without stifling recovery.

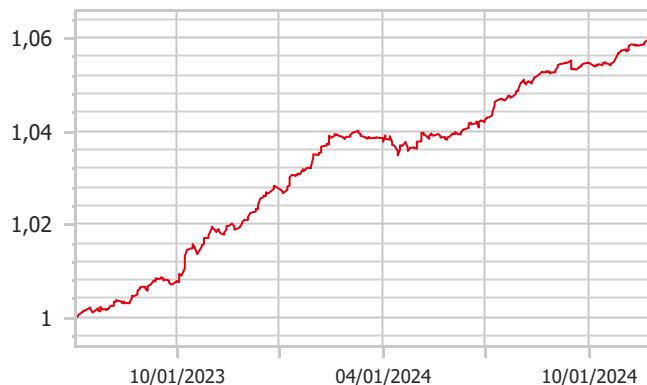
