## INVESTMENT POLICY OF THE FUND

The Fund aims to increase the value of its assets under management and to provide investors with a higher yield than Czech bank deposits and short-term bonds over a period of 1 to 2 years. No individual investor's decisions can be made in the Fund. The Fund Manager selects portfolio elements in accordance with the above principles. When making investment decisions, the tools of fundamental analysis and technical analysis are used, and the current market sentiment is also taken into account. The Fund primarily invests in discount treasury bills issued by the Czech State, sovereign bonds, bonds of guasi-sovereign companies, or bonds or deposit-like instruments issued by the Czech National Bank, the European Central Bank or the central bank of another Member State of the European Union. To a limited extent, the portfolio may include government securities, state-guaranteed bonds, corporate bonds (including those issued by financial institutions) and mortgage bonds with at least investment-grade credit rating. Investments may be made in Czech crowns or, to a limited extent, in other currencies. In the case of assets denominated in a currency other than Czech crowns, the Asset Manager shall strive to fully hedge foreign exchange risks (there cannot be a difference of more than 5% between the currency exposure of the derivative transaction and that of the asset to be hedged).

The Fund may enter into deposit and repo transactions, invest - to a limited extent - in units in collective investment undertakings, and derivatives may as well be used (for the purposes of hedging or building an efficient portfolio).

#### MARKET SUMMARY

The Czech National Bank (CNB) has paused its rate-cutting cycle, holding the two-week reported at 4.00% after reducing it from its 7.00% peak since December 2023. This decision, widely anticipated by analysts and markets, saw dissent from two policymakers advocating for a further 25bp cut. The pause reflects the Bank Board's assessment of persistent inflationary pressures, with inflation expected to stay above the 2% target until the end of 2026. Concerns about price pressures in the services sector and an incomplete disinflation process in core components influenced the decision, as highlighted in the accompanying statement. Governor Ales Michl emphasized that the pause does not mark the end of the easing cycle, leaving the door open for a potential rate cut at the February meeting. The decision will hinge on upcoming data releases, including December CPI (January 13), January flash CPI (February 6), and insights from the new Monetary Policy Report. While the underperformance of the German economy and subdued external demand act as anti-inflationary forces, these risks are balanced against domestic price pressures. The CNB Board remains cautious, with the February meeting likely to evaluate whether conditions warrant resuming rate cuts or maintaining the pause. Monetary policy of ECB will be likely supportive for further rate cuts, however potentially strong US data, and Trump's expected policy mix may prevent FED from further rate cuts in the coming months, which may lead to cautious monetary policy in the Czech Republic as well.
