

INVESTMENT POLICY OF THE FUND

The objective of the investment fund is to make the Polish bond market accessible to the investors, and to function as a relatively stable, medium-risk investment form bringing steady real yields to our Clients on middle term already, without having to tie down their money for a fixed period of time. The Fund mainly invests in Polish government securities issued in zloty, however, the portfolio manager has some room to complement the portfolio with other bond-type investments. Our goal is to achieve the highest yield while taking the lowest risk. To make investment decisions we use the tools of both fundamental and technical analysis, and we take into consideration the investor sentiment on the markets at all times. The portfolio manager seeks out potential investment opportunities based on the macro-economical expectations, the expected yield curve, the return expected on the curve and the market volatility, and selects investments that are considered to be safe and bring relatively high yields in exchange for the risks taken. The Fund strives for complete exchange risk coverage of foreign currency exposure for the target currency.

MARKET SUMMARY

The performance of the Polish bonds was strong in the February: yields fell by 6 basis points on the 3-year maturity, and by 10 and 8 basis points on the 5- and 10-year maturities, respectively. The base rate is still at 5.75% and at the rate setting meeting in February it was left unchanged as well. Although no rate cuts are expected in the near future, a somewhat softer tone could be detected in the central bank governor's communication. They do not know when, but rate cuts will eventually come. Inflation in Poland also started the year with an increase, with a year-on-year price rise of 5.3% in January. The higher than market consensus price increase was mainly driven by higher food, energy, and fuel costs. The Purchasing Managers' Index (PMI) rose to 50.6 in February from 48.8 the previous month, exceeding market expectations. This is the first time since April 2022 that the index has moved above the 50 threshold, placing it in the expansion territory. Both output and new orders increased, and exports declined at a slower pace. Industrial production fell by 1% in the first month of the year. As for the state budget, the government generated a deficit of 3,205.6 million PLN in the first month of the year, bringing the 12-month rolling budget deficit to 6.5% of GDP. We adopted a more constructive stance during the month, as U.S. yields staged a significant rally, while Polish yields showed much smaller movements. The 10-year Polish yield remains relatively close to the upper end of its recent range, while the Polish government has made strong progress with this year's issuance plan. Additionally, its substantial cash reserves provide flexibility to mitigate potential yield increases by postponing auction supply if needed.

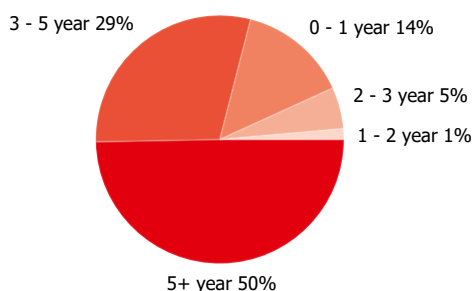

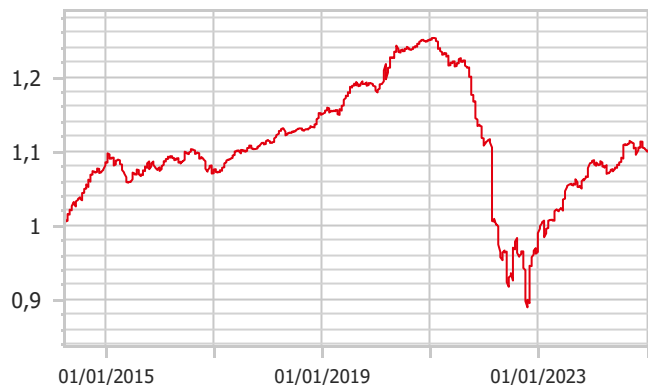
