## INVESTMENT POLICY OF THE FUND:

The fund's aim is to assemble an investment portfolio for its investors that is comprised of both Hungarian and international money and capital-market instruments, which the fund can optimise through ongoing dynamic asset allocation in order to attain the highest possible yield. The fund is a 'total-return fund', which means that instead of concentrating on just one subsector of the money or capital market, at any given moment it focuses its investments on the area that holds the promise of the highest possible return. Accordingly, the fund may hold government securities and discount treasury bills issued by the State Debt Management Centre (ÁKK) on behalf of the State of Hungary, as well as bonds issued by the National Bank of Hungary, and also bank and corporate bonds that are low risk but are nevertheless likely to earn a higher return than government securities. Besides these the fund's portfolio may also contain shares listed on the domestic stock exchange and the bourses of OECD countries, as well as the government securities, bank and corporate bonds of OECD countries. The fund does not follow a fixed benchmark, and does not adhere to a permanent ratio of shares to bonds, but aims to constantly change this ratio within a broad range; indeed, it is also prepared to take on currency risk (just as international bond/equity funds tend to) through the purchase of international government securities and equities. At the same time, the fund maintains the option to hedge currency risks.

#### MARKET SUMMARY:

Market sentiment was dominated by the conflict between Russia and Ukraine and the surrounding political tensions. Risky assets performed badly, safe havens were in demand, precious metals and core market bonds gained. As tensions eased equities marched further, particularly EM equities rallied as valuations and positioning both helped. The climate was also favourable for EM bonds: core market long yields were stable, capital outflows slowed, and several markets experienced significant selloffs which could be a good entry point. US rate hike expectations come closer while the ECB is rather inclined to further easing amid low inflation prints. We still keep our US 10y short and bet on USD strength, altough we took some profit on this trade. In our equity allocation we preferred EM equities, our Turkish holdings produced a nice return. Local fixed incoe market also showed signs of stabilisation, we hold on to our holdings that are concentrated on the mid-curve.
