

INVESTMENT POLICY OF THE FUND:

The fund's aim is to assemble an investment portfolio for its investors that is comprised of both Hungarian and international money and capital-market instruments, which the fund can optimise through ongoing dynamic asset allocation in order to attain the highest possible yield. The fund is a 'total-return fund', which means that instead of concentrating on just one subsector of the money or capital market, at any given moment it focuses its investments on the area that holds the promise of the highest possible return. Accordingly, the fund may hold government securities and discount treasury bills issued by the State Debt Management Centre (ÁKK) on behalf of the State of Hungary, as well as bonds issued by the National Bank of Hungary, and also bank and corporate bonds that are low risk but are nevertheless likely to earn a higher return than government securities. Besides these the fund's portfolio may also contain shares listed on the domestic stock exchange and the bourses of OECD countries, as well as the government securities, bank and corporate bonds of OECD countries. The fund does not follow a fixed benchmark, and does not adhere to a permanent ratio of shares to bonds, but aims to constantly change this ratio within a broad range; indeed, it is also prepared to take on currency risk (just as international bond/equity funds tend to) through the purchase of international government securities and equities. At the same time, the fund maintains the option to hedge currency risks.

MARKET SUMMARY:

Macro trends of developed markets are still positive, though price action of risky assets was dominated by news coming from Ukraine. Due to lack of inflation pressure the Fed can delay its more restrictive monetary policy, moreover, the possibility of a quantitative easing coming from the ECB is increasing. Carry trade was supported by stable yields of developed market bonds and low volatility, therefore after the sell off at the beginning of the year EM bonds and currencies had a strong performance in April. Domestic bond market performed well too, mainly thanks to the new programme of the NBH, which is expected to boost demand of forint denominated bonds, while FX issuance is expected to be delayed for a significant period. The bond position of the Fund performed well, meanwhile we held the proportion of the equity low after the EM rally came to a halt at the middle of the month, and geopolitical tensions casted a shadow on risky assets.
