

INVESTMENT POLICY OF THE FUND:

The fund's aim is to assemble an investment portfolio for its investors that is comprised of both Hungarian and international money and capital-market instruments, which the fund can optimise through ongoing dynamic asset allocation in order to attain the highest possible yield. The fund is a 'total-return fund', which means that instead of concentrating on just one subsector of the money or capital market, at any given moment it focuses its investments on the area that holds the promise of the highest possible return. Accordingly, the fund may hold government securities and discount treasury bills issued by the State Debt Management Centre (ÁKK) on behalf of the State of Hungary, as well as bonds issued by the National Bank of Hungary, and also bank and corporate bonds that are low risk but are nevertheless likely to earn a higher return than government securities. Besides these the fund's portfolio may also contain shares listed on the domestic stock exchange and the bourses of OECD countries, as well as the government securities, bank and corporate bonds of OECD countries. The fund does not follow a fixed benchmark, and does not adhere to a permanent ratio of shares to bonds, but aims to constantly change this ratio within a broad range; indeed, it is also prepared to take on currency risk (just as international bond/equity funds tend to) through the purchase of international government securities and equities. At the same time, the fund maintains the option to hedge currency risks.

MARKET SUMMARY:

Global liquidity exuberance continues and the low rate of volatility keeps supporting emerging markets fixed income and FX In spite of the good performance of the US economy the Fed tries to continue its exit strategy very carefully and gradually, while the ECB attempts to stimulate the Eurozone economy, weaken the EUR and stop disinflation with cutting rates and providing another LTRO. Equities like this market mix, both developed and emerging market indices closed the month higher.

In the fund we rather increased the weight of corporate bonds and left equity exposure roughly unchanged. We sold our MTELEKOM shares and bought some of the offered MOL papers. We keep our short position in 10-year US Treasuries and our short HUF position broadly unchanged.
