INVESTMENT POLICY OF THE FUND:


NET PERFORMANCE OF THE FUND

MARKET SUMMARY:

The rate cut rally continued in September. Although rising US yields caused some wekaness on the long end, direction is still down. The market now prices an easing of 75 bps as the ten year bond traded below 3% albeit closing the month higher. ECB measures help: both the surprise rate cut and the planned ABS program support the bond market. Deteriorating Eurozone growth can be another worry for the decision makers besides the Ukraine-Russia conflict, we tend to believe easing can be even more than currently priced, but the curve starts to look less and less cheap.


