INVESTMENT POLICY OF THE FUND:

The fund's aim is to assemble an investment portfolio for its investors that is comprised of both Hungarian and international money and capital-market instruments, which the fund can optimise through ongoing dynamic asset allocation in order to attain the highest possible yield. The fund is a 'total-return fund', which means that instead of concentrating on just one subsector of the money or capital market, at any given moment it focuses its investments on the area that holds the promise of the highest possible return. Accordingly, the fund may hold government securities and discount treasury bills issued by the State Debt Management Centre (ÁKK) on behalf of the State of Hungary, as well as bonds issued by the National Bank of Hungary, and also bank and corporate bonds that are low risk but are nevertheless likely to earn a higher return than government securities. Besides these the fund's portfolio may also contain shares listed on the domestic stock exchange and the bourses of OECD countries, as well as the government securities, bank and corporate bonds of OECD countries. The fund does not follow a fixed benchmark, and does not adhere to a permanent ratio of shares to bonds, but aims to constantly change this ratio within a broad range; indeed, it is also prepared to take on currency risk (just as international bond/equity funds tend to) through the purchase of international government securities and equities. At the same time, the fund maintains the option to hedge currency risks.

MARKET SUMMARY:

October was dominated by a selloff in equity markets driven by the weakness of US indices, particularly tech papers. The risk off sentiment was driven by global and US growth fears amid weaker data, higher US real yields and EU-Italy tensions. We further reduced our spread expoure in the fund and switched to the new Ukraine issue for some new issue premium. We closed part of our developed market yield shorts before the risk off episode and opened short positions on S&P which we closed with a profit. We tried to buy the dip too early though and were stopped out of the reversed postion. We expect markets to remain choppy in the remainder of the year with deteriorating macro data less supportive for markets.
