INVESTMENT POLICY OF THE FUND:

The aim of the fund is to function as a stable low-risk investment vehicle, but to offer investors better returns than the performance of the current benchmark index, which may differ from interest rates depending on market conditions. The fund is a standard variable net asset value money market fund. The portfolio elements are selected in accordance with the above mentioned principles and based on the EU wide regulation on money market funds. To ensure liquidity the fund manager primarily aims to hold government bonds and discount treasury bills issued by the Government Debt Management Agency (ÁKK), and short-term instruments (e.g. deposits, repos) available on the interbank market. The fund is low-risk, but its portfolio may also contain mainly forint-, but also other foreign currency denominated debt securities issued by banks and corporations, which are expected to ensure a higher return than government securities. To a limited extent, the fund may also invest in bonds issued or guaranteed by the OECD or G20 countries, any central-, regional- or local governments and national banks of the EU and also by the European Union, the European Central Bank or the European Investment Bank. The fund may hold securitisations, asset-backed commercial papers and also investment units and shares within the framework of the Money Market Funds Regulation. The Fund shall have a weighted average maturity no more than 6 months, and a weighted average life no more than 12 months. Moreover, the Fund shall also be allowed to invest in money market instruments with a residual maturity until the legal redemption date of less than or equal to 2 years, provided that the time remaining until the next interest rate reset date is less than or equal to 397 days. The fund may hold a limited proportion of foreign-currency instruments in its portfolio, but only subject to the full hedging of currency risk (the difference between the currency risk exposure of the derivative instrument and the hedged instrument can be maximum 5%). Aegon Moneymarket Fund is not a guaranteed investment. The risk of loss of the principal is to be bome by the investor. 

In December, inflation came as no surprise, with consumer prices were 2.7% higher than a year earlier. Thus, the average annual inflation in 2020 was 3.3%. The pace of the price increases may remain low in the first quarter, but may rise above 4% from the second quarter due to base effects and because of the indirect tax increases. As a result, the central bank left both the key rate and the one-week deposit rate unchanged during the month. In January, 3- and 12-month FX-implied yields rose by 15 basis points. Average yields on 3-month T-bill auctions rose from 31 basis points to 36 basis points, while average yields on the annual T-bill auctions stabilized around 41 basis points. The oversubscription rate for the new issues ranged between 1 and 1.5 during the month. In the one-week deposit tenders held on Thursdays in January, all bids submitted were accepted by the central bank.
