MARKET SUMMARY

Emerging market sovereign and corporate bonds had a decent month in June. The mostly watched event during the month was of course the FOMC meeting where the market was eagerly waiting for any sing that the Fed are even contemplating about changing its tone in the light of the recent consumer price developments. The meeting managed to deliver quite a big surprise as FOMC members updated their base rate forecast which implied that the members see the developments around the economic environment that warrants a somewhat more hawkish stance than before. The Fed was succesful in guiding long term inflation expectations and inflate somewhot short term rates exoexctations. As a result the US treasury yield curve flattened significantly and totally wiped out the year-to-date steepening. The move had different impacts on the different assets classes. As mentioned, both corporates and sovereigns closed a positive month in USD, however the FOMC meeting had its toll on the EM currencies which posted negative return in June. The oil price increase also helped the EM space somewhat.

In emerging europe the overall positive sentiment towards high spread/high yielding assets helped Turkey and Ukraine. In Ukraine more positive news came out regarding the judiciary reform.

We slightly changed our stance towards emerging market credit. We sold our Ghana long end exposure and we stayed in cash as positioning is streched, primary issuance is flaring up again and we expect more data driven trading that could lift volatility.

INVESTMENT POLICY OF THE FUND

The fund's investment objective is to provide investors with a higher return than that attainable in the domestic money market, primarily by investing in the bond market of the Central and Eastern European region. The fund's bond investments are mainly concentrated in the corporate and mortgage bond markets, but government securities issued in foreign currency are also potential investment targets. Forint-denominated Hungarian government securities are only held for liquidity management purposes. The fund may also buy into other investment funds that invest in the above markets. The achievement of a higher return than would be attainable in the Hungarian government securities market is made possible by the better diversification, the additional yield from the premiums of the bonds, and, in a favourable market environment, by the price gains resulting from the narrowing of the premiums.

The fund's general risk level and the asset allocation between the three main areas of investment is determined on the basis of a regular market analysis and situational analysis relating to four main aspects (fundamentals, valuation levels, market sentiment, technical factors). The in-depth analysis is also an important factor in the selection of the individual securities by region, sector and interest risk. In the course of selecting the individual securities, a thorough financial analysis is also essential to determine the creditworthiness of the issuer. Risk management and the regular monitoring of the issuers are of key importance to the fund. When compiling the fund's portfolio we aim to achieve a moderate risk profile, primarily purchasing investment-grade securities. The fund only buys lower-rated instruments in limited proportions.

The fund may only conclude derivative transactions for the purpose of hedging or ensuring an efficient portfolio structure. The fund may also hold unleveraged collective investments linked to derivative indexes. The fund also has the option of taking on a substantial currency exposure, which will ordinarily be fully hedged, although depending on market circumstances the fund may even have an open currency position.

The fund management company, exercising all due care, based on its own judgement and decisions, and while observing the relevant legal provisions and the limitations stipulated in the Fund Documentation, determines the means of utilising the fund's resources, and the weights of the various investments within the portfolio, with a view to ensuring that the fund - in line with our expectations with regard to future risks and returns - achieves its objective in the long term.


